Deputy JOSE ANTONIO DIAZ

End of Watch: June 15, 2008

Cause: Gunfire





Deputy Tony Diaz was shot and killed while making a traffic stop near the intersection of County Road 5 and County Road 99W at approximately 9:30 pm.

After a five-minute high speed pursuit, the suspect exited his vehicle and opened fire on Deputy Diaz, penetrating his vest, striking him in the shoulder.

Despite his wound, Deputy Diaz was able to call for assistance. He was transported to a local hospital where he succumbed to his injuries.

The suspect, who fled on foot after abandoning his infant in his car, was apprehended

a short time later. On October 4, 2011, the subject was convicted of multiple charges, including murder of a peace officer. The jury recommended he receive the death penalty and in February 2012 the presiding judge subsequently upheld the sentence.

Deputy Diaz had served with the Yolo County Sheriff's Department for four years. He is survived by his three children.


Police Officer JAMES H. MCKNIGHT

West Sacramento Police Dept.

End of Watch: June 16, 1990

Cause: Gunfire





Officer James McKnight was shot and killed while serving a warrant with the Yolo County Narcotics Enforcement Team in the town of Madison Yolo County. The suspect was also shot and killed. Officer McKnight died of his wounds on June 16, 1990.

Officer McKnight had served with West Sacramento Police Department for 3 years. Officer McKnight had previously served with the Yolo County Sheriff Department, Woodland Police Department and a Police Department in the State of Hawaii. Officer McKnight was also a graduate of McGeorge School of Law in Sacramento.

He is survived by his wife and three children.

Motor Officer LAWRENCE L. SILLS

End of Watch: June 13, 1945

Cause: Motorcycle Accident





Motor Officer Sills died from injuries received in a motorcycle accident while pursuing a suspect vehicle. He hit a patch of loose gravel and lost control of his motorcycle. Hospitalized as a result of the injuries he sustained, he passed away on June 13th.

Officer Sills was born in College City and he graduated from Yuba College in Marysville before joining the Woodland Police Department.

Officer Sills was survived by his wife and two daughters.

Happy Retirement Chaplain Robert Duvall and K-9 Kepi!



On May 28, first responders recognized the service of Chaplain Robert Duvall who began volunteering with Winters in September of 2013.

Robert has been a great asset to our first responders and our community, we wish him joy in his retirement.

Chaplain Robert Duvall served as the handler for the Chaplain/ Crisis Intervention Team for the Winters Public Safety Crisis Intervention Team. He began his career in the 1980s as a Paramedic for the City of Richmond, CA. He retired in 2012 from the Contra Costa County Sheriff Office. In over 20 years in Public Safety, he saw first-hand the struggle of first responders to maintain their emotional, mental, and overall wellbeing. He decided that there needed to be a resource available to first responders, applied for, and received a specially trained canine. K-9 Kepi and Chaplain Robert Duvall went into service January 1, 2016 as a State Certified Crisis Intervention Team.

K-9 Kepi was specifically paired with Chaplain Duvall due to her ability to sense emotional stress, a talent that was heightened during her three week training course. She has been trained to provide both active (moving to be touched) and passive (sitting still) emotional support.

The team often was dispatched to assist with calls that have a traumatic component. Examples of calls included death notifications, serious traffic collisions, assaults, homicides, and crimes involving children. The Team's unique combination of Chaplaincy and Crisis Intervention provided much needed support for our first responders and our communities.

95% of wildfires in California are started by people. Be conscious and vigilant when you use equipment, when it comes to your vehicle, when you burn debris, and practice campfire safety.






